## Instructions for Withdrawing Minor Funds

The following documentation is needed in order to process your application. **Our office will not accept incomplete applications.**

- An original birth certificate. If your birth certificate is written in a language other than English, it must be accompanied by a notarized English translation
- A certified copy of your marriage license if you are now married
- Form W-9\*
- Motion\*
- Order \*
- Picture Identification: state issued driver's license, DPS I.D. receipt, state identification card, passport, military ID.
- Social Security Card (photocopy if application is mailed)

### If applying by mail:

Send in the completed Motion and Order, W-9, birth certificate or marriage license and a notarized photocopy of the applicant's state picture ID. (*The applicant should sign the copy in front of a notary and have the signed paper notarized.*)
