ORDER OF ASSIGNMENT BY THE PRESIDING JUDGE

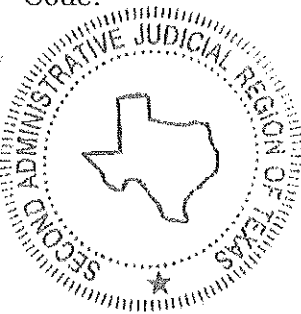
